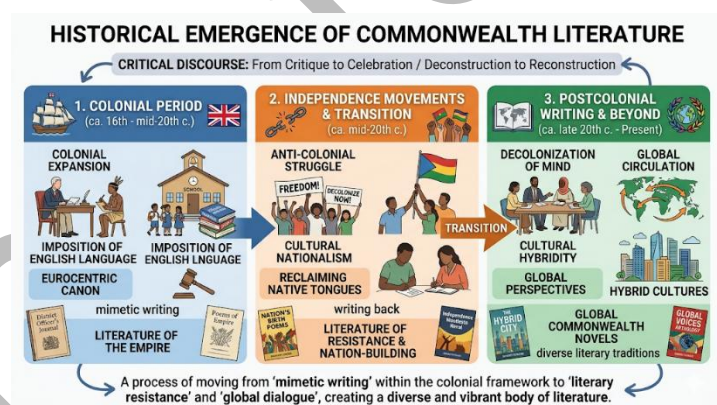


Figure 1.1: Historical background of Commonwealth literature

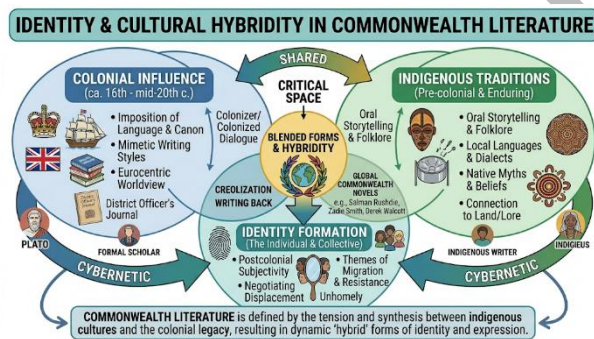


Figure 1.2: Identity and cultural hybridity in Commonwealth literature

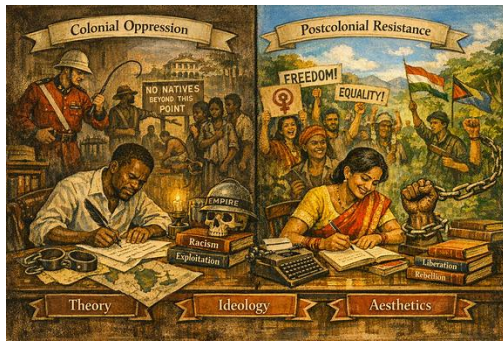


Plate 1.2: Racism, colonialism, and postcolonial struggles in literature

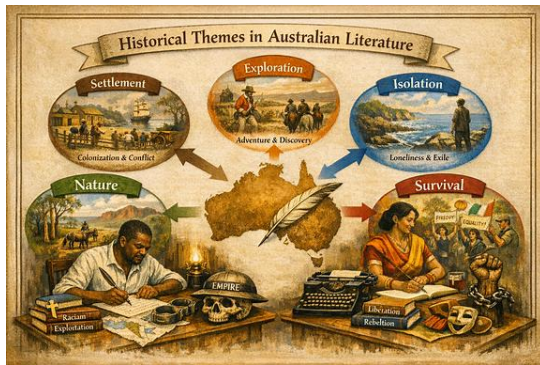


Figure 2.1: Historical background and themes in Australian literature

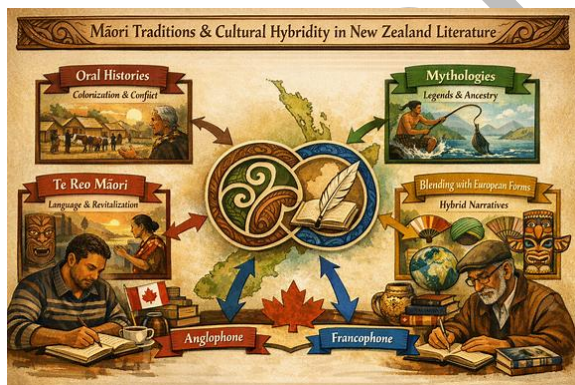


Figure 2.3: Maori traditions and cultural hybridity in New Zealand literature

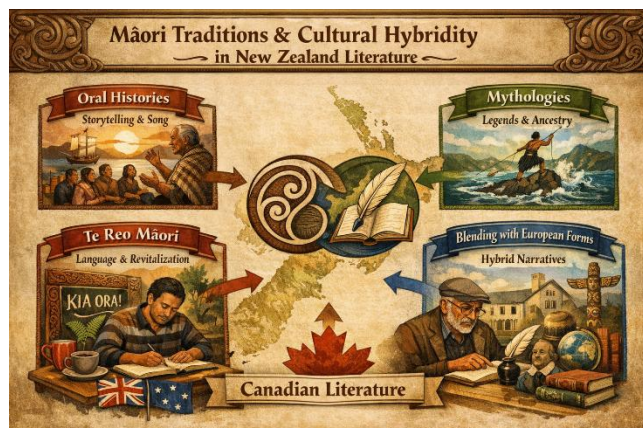


Plate 2.3: Colonial legacies and national identity in New Zealand literature

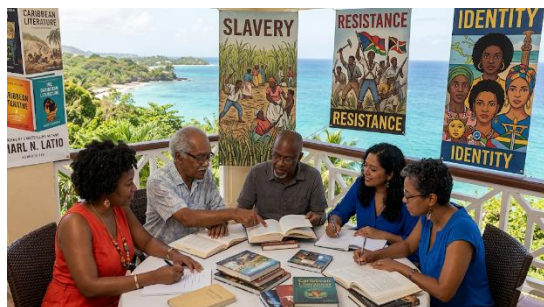


Plate 2.4: Themes of slavery, resistance, and identity in West Indian literature

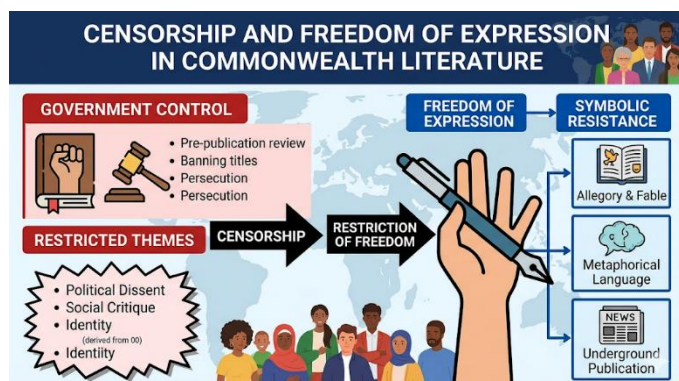


Figure 3.1: Censorship and freedom of expression in Commonwealth literature

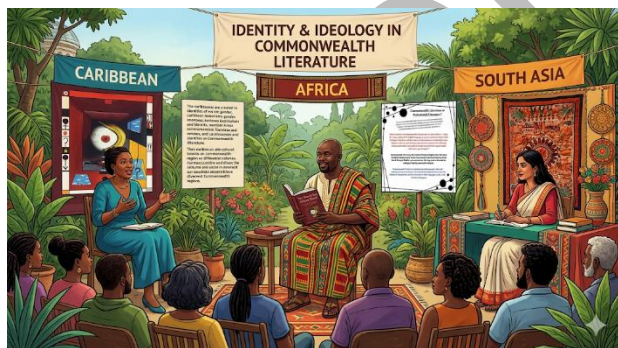


Plate 3.1: Representation of identity and ideology in Commonwealth literature

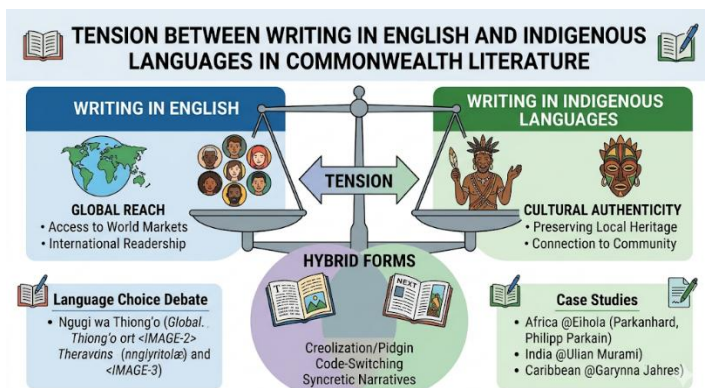


Figure 3.2: Language choice in Commonwealth literature

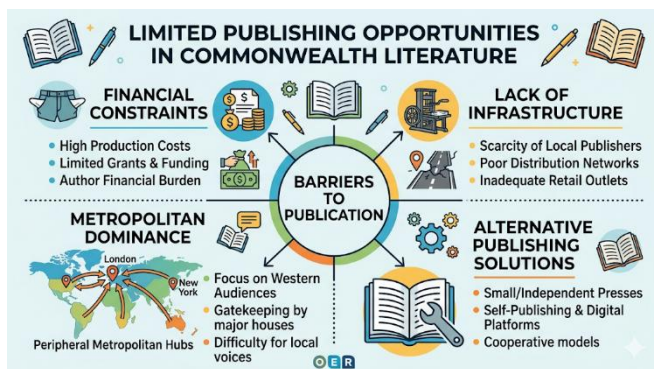


Figure 3.3: Limited access to publishing opportunities in Commonwealth literature

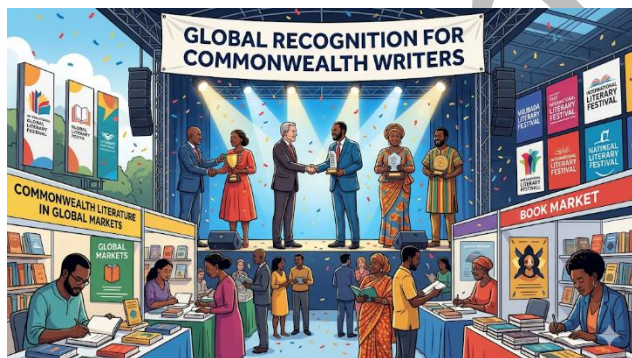


Plate 3.3: Global recognition and market competition in Commonwealth literature

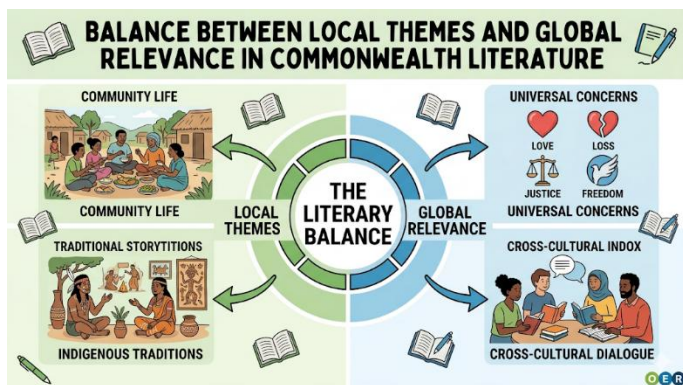


Figure 3.4: Balancing local themes with global relevance

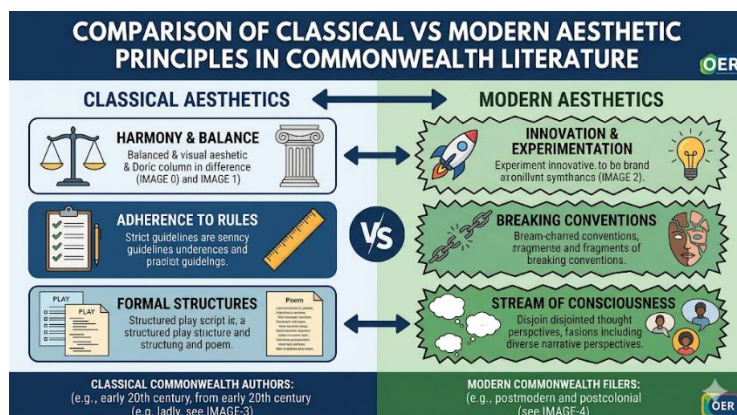


Figure 4.1: Classical and modern aesthetic principles in Commonwealth literature

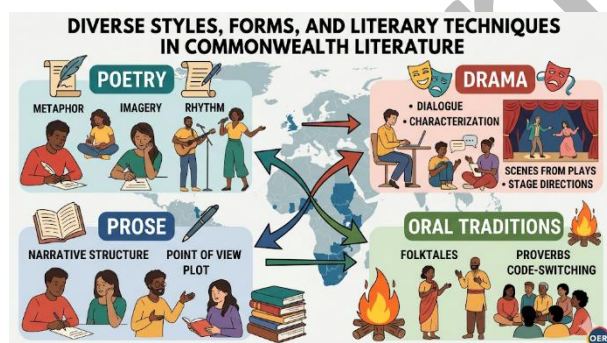


Plate 4.1: Style, form, and literary techniques in Commonwealth literature

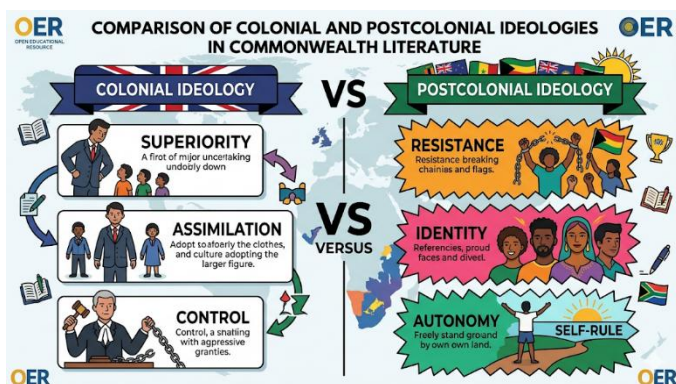


Figure 4.2: Colonial and postcolonial ideologies in Commonwealth literature

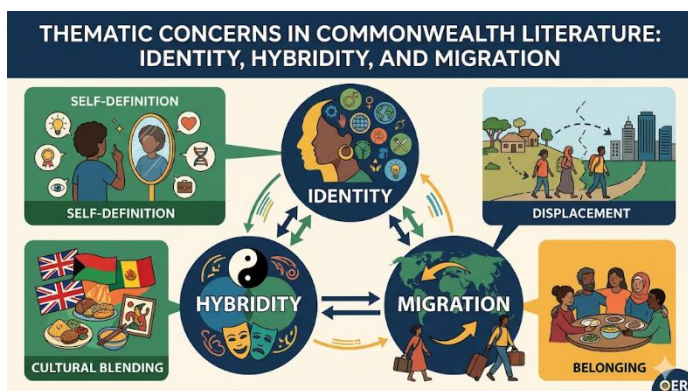


Figure 4.3: Identity, hybridity, and migration in Commonwealth literature

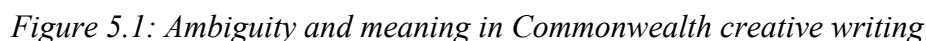

5.2 Cross-Cultural Semantics In Commonwealth Literature

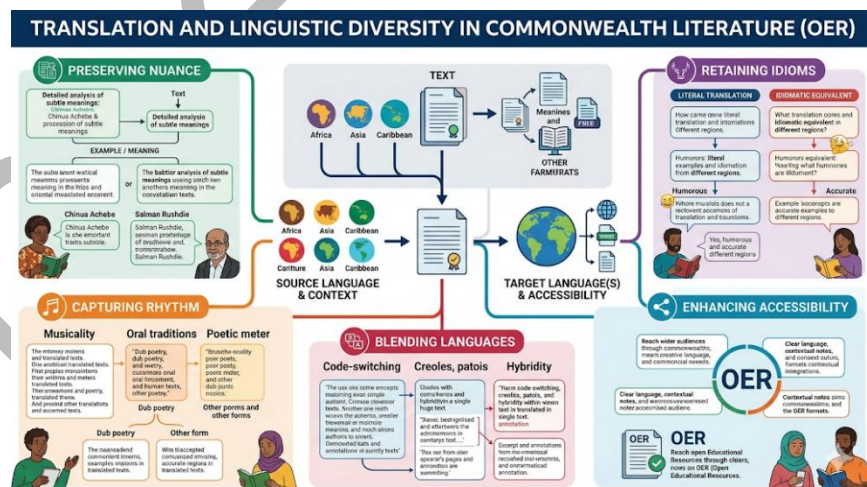


Figure 5.2: Translation and linguistic diversity in Commonwealth literature

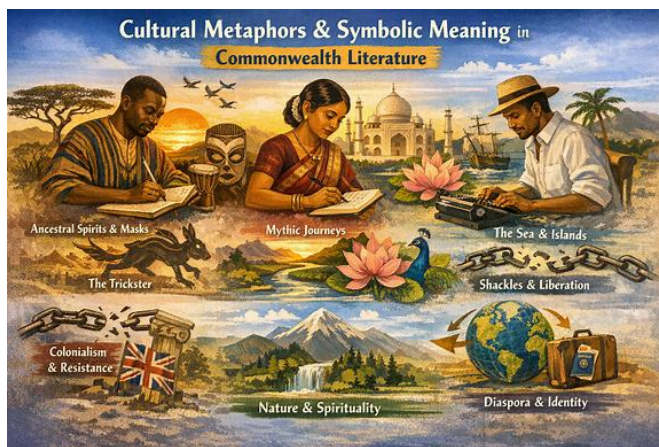


Plate 5.2: Cultural metaphors and symbolic meaning in Commonwealth literature

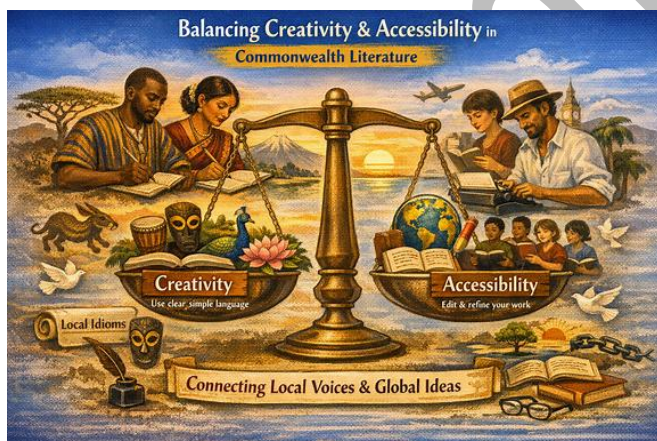


Plate 5.3: Balancing creativity with accessibility in Commonwealth creative writing
